Action: Notice of Violation No. 0512043
Resolution: Stipulation and Consent Order No. 0605021 and penalty of \$2875.00 paid.

Inspection: September 19-29, 2005
Issues: • (1) Failure to label hazardous waste accumulation containers with accumulation start dates and with the words "Hazardous Waste" or the specific chemical constituents.
(2) Failure to maintain hazardous waste accumulation containers in a closed condition.
(3) Failure to ship hazardous waste off-site within 90 days of start accumulation date.
(4) Failure to perform weekly inspections.
(5) Treatment of a waste without a permit

Action: Warning Letter No. 0511036
Resolution: No formal resolution required.

Inspection: September 14, 2005.
Issues: • (1) Used Oil - operation of used oil boiler for non-energy recovery purposes.

Action: Warning Letter No. 0412042
Resolution: No formal resolution required.

Inspection: September 20-28, 2004.
Issues: • (1) Four boxes of waste without proper labeling.
(2) Two drums of waste were over the 90 day generator storage limit.

Action: Warning Letter No. 9905012

Resolution: No formal resolution required.

Inspection: September 17 - 18, 1998

Issues: • (1) Failure to maintain in a closed fashion three hazardous waste containers.

Action: Notice of Violation No. 9309054

Resolution: Stipulation and Consent Order No. 9403008 and penalty paid of \$20,000.00.

Inspection: May 8 - 13, 1993.

Issues: • (1) Failure to make a hazardous waste determination on 600 lbs of waste
(2) Offering for shipment hazardous waste to a transporter which did not have an EPA Identification Number.
(3) Failure to use an 'Uniform Hazardous Waste Manifest' when offering hazardous waste for transportation.
(4) Offering hazardous waste to an unpermitted treatment, storage, disposal facility which did not have an EPA Identification Number.

Action: Notice of Violation No. 9302016

Resolution: Resolution provided by written response.

Inspection: August 10 - 13, and 18, 1992.

Issues: • (1) Failure to make a hazardous waste determination.
(2) Failure to manage a hazardous waste beyond 90 days with a permit or interim status.
(3) Failure to maintain a hazardous waste container in a closed fashion.
(4) Failure to properly record data in the DRMO storage operating record.
(5) Failure to properly document the training status of an employee working with hazardous waste.
(6) Failure to provide an annual review of initial hazardous waste management training for an employee working with hazardous waste.
(7) Failure to provide job description information in the training records for an employee working with hazardous waste.

Action: Notice of Violation No. 9206122

Resolution: Resolution provided by written response.

Inspection: September 16 - 19 and November 13, 1991.

Issues: • (1). Failure to make a hazardous waste determination on 500 gallons of waste at the IWTP.
(2) Storing hazardous waste in open containers at six different location.
(3) Storing hazardous waste in containers with start accumulation dates at ten

locations.

- (4) Storing hazardous waste in containers that were not labeled or marked clearly with the words, "Hazardous Waste", or identifying the chemical constituents by name at three locations.
- (5) Failure to submit a report to the Executive Secretary before the expiration of the seventy-two hour reporting time frame limit the repair schedule for repairing a cracked concrete berm in the permitted hazardous waste storage facility.
- (6) Failure to document in the DRMO personnel training records that employees had received the required training within six months of their hire date prior to working in areas of hazardous waste management.
- (7) Failure to accurately record in the permitted hazardous waste storage facility 'Operating Record' the location of a container of hazardous waste accepted for storage.

Action: Notice of Violation No. 9011007

Resolution: Resolution provided by written response.

Inspection: September 20, 1990.

- Issues:** •
- (1). Failure to mark a container.
 - (2) Failure to maintain in the files a copy of a LDR notification.
 - (3) On two occasions the hazardous waste storage facility's capacity was exceeded.
 - (4) Failure to limit container stacking to one high in the hazardous waste storage facility.
 - (5) Failure to meet deadlines for submittal of documents.
 - (6) Failure to obtain written approval to change reporting forms.
 - (7) Failure to follow reporting procedures for malfunctions or deteriorations discovered.

Action: Notice of Violation No. 8911926

Resolution: Resolution provided by written response.

Inspection: September 25, 1989.

- Issues:** •
- (1) Failure to clearly label a container holding hazardous waste with the words "Hazardous Waste"
 - (2) Failure to clearly mark a container holding hazardous waste with the date upon which accumulation started.
 - (3) Failure to store only wastes described in their Part-B permit

Action: Notice of Violation No. 8905722

Resolution: Resolution provided by written response.

Inspection: March 21, 1989

Issues:• (1) Offering hazardous waste to a transporter which did not have an EPA Identification Number.

Date: August 11 & 26, 1993

Inspection: A RCRA CEI Inspection was conducted by UDEQ.

Issues:• Boxes of propellant cuttings at Bldg 1952 were not properly labeled with the words “hazardous waste” or dated.

Inspection: UDEQ conducted a “SWMU hunt” (an abbreviated version of an RFA) looking for sites that should be included in the corrective action portion of the RCRA Storage Permit.

- Action:** A Notice Of Violation (NOV) and Order for Compliance was issued to Hill AFB on 2 April 1993.
- Resolution:** Hill AFB submitted letters of response to the issues and violations on 30 April 1993 and 15 June 1993. In a letter dated 8 July 1993 UDEQ provided an evaluation of Hill AFB's response and closed the inspection / NOV
- Inspection:** August 10 - 13 & 18, 1992
(A Multi-Media Inspection was conducted by the UDEQ (Solid and Hazardous waste, Water Quality, and Air Quality), Utah Department of Agriculture (Pesticide Application), EPA Region-VIII, and the Davis County Health Department.)
- Issues:**
- (1) Potential releases to the environment from operations at Fire Training Area 2, information was requested on operations and analytical on residue collected in the lined storage impound.
 - (2) Request analytical on waste with P030 waste code which operators said was an error.
 - (3) Request copies of manifests for sludge removed from the two closed drying beds at the IWTP.
 - (4) Failure to make a hazardous waste determination on solvent contaminated rags at Bldg 5.
 - (5) Accumulation of hazardous waste at Bldg 5 for more than 90 days without a permit, site K10B.
 - (6) Accumulation of hazardous waste in an open container, site N11A, Bldg 5
 - (7) Failure to accurately record the location of two drums inside the permitted hazardous waste storage facility
 - (8) Failure to document personnel training for employees with hazardous waste management responsibilities, and provide them with annual review classes, and provide job title and job descriptions for those employees.
